

Privacy policy

for your personal data stored by Unic Rotarex®

This policy is based on the requirements of Law no. 677/2001 on the protection of individuals with regard to the processing of personal data and the free circulation of such data.

Personal data collected by Unic Rotarex® (in written or electronic form) are solely controlled by us, are not transmitted to third parties and are not made public.

This policy applies to all personal data collected in connection with the services and products we offer.

1. What personal data do we collect?

Personal data is information that identifies a person, directly or indirectly.

You are not required to provide your personal data to Unic Rotarex®. If you choose not to provide the needed personal data, you can not benefit from the products or services offered by Unic Rotarex®.

Personal data collected by us may include:

- data you give us directly we collect data that we receive from you with the purpose of issuing offers, such as name, address, telephone number, email address, only with your consent, see the form on "Contact us" page from our website (www.roprofil.com).
- data we automatically collect we collect data when you interact with us online. Data on how you use our site: the type of content you are viewing, the frequency or duration of visits on the site, the IP address, the device used, the location, the type of browser used, the operating system used. Automatically collected data is available to third parties for operational purposes, such as online site hosting providers or online performance analysis companies.

2. For what purpose do we use your data?

We collect your personal data for specific and limited purposes. For example, to sign a sale-purchase agreement, to improve our products and services, our communication methods, or the functionality of our website.

WE do not collect your personal data without your consent, see "<u>Terms of Use</u>", you have the right to withdraw your consent at any time (unless you are in a contract with us) or request access to your stored data (by the form on "Terms of Use" page).

We may transfer your data to third parties in the following cases:

- to respond to a legal obligation;
- for anti-fraud detection or protection or in case of technical failures.

3. How do we protect your personal data?

Data collected from you may be processed automatically or manually according to all legal and safety restrictions. In this regard, appropriate technical and organizational measures are taken to protect your personal data.

These can refer to: name and surname; address; phone number; email address; ID number.

Our measures include limiting access to these data, investing in online security systems such as antivirus (Bitdefender). Access to personal data is only allowed for part of our staff, trained in this regard. Access to the email address on which we receive your personal data is also limited. 4. What is the duration of personal data storage?

Unic Rotarex® retains your personal data only for the time it takes to process it. For example, if you make a request on our site, your data will be retained for a period of time that we deem necessary to have a working relationship with you. In the case of a contract, your personal data will remain archived in the contract for the requested period by law
